General Instruction / Terms & Condition.

1. The candidates should read carefully the eligibility and experience criteria etc. laid down in the advertisement before appearing/applying for these posts. Maximum age for the candidates will be sixty five years.

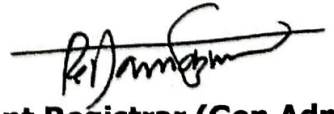
